In 1996, the City of Anaheim created the Helping Hands Program. This program offers residents and businesses the opportunity to make a tax-deductible donation concurrently with the payment of their utility bill to assist local programs directed at youth and seniors and to assist less fortunate Anaheim residents with one-time utility bill payments. The Anaheim Community Foundation was asked by the City Council to receive and disburse funds collected under this program.

The Foundation allocates funding for organizations that serve Anaheim residents. Please review the Helping Hands Program Guidelines for details on the qualifications.

Helping Hands grant applications are available online at www.anaheimcf.org. The President or Chair of your organization's Board of Directors must sign Grant applications. In lieu of that, please include a letter signed by the President or Chair of the Board of Directors stating that they and the organization approve of the grant submission. Applicants must provide one (1) original and two (2) copies of their grant applications, stapled and 3-hole punched. Incomplete grant application forms will not be accepted. All funded organizations will be required to provide an annual report, providing documentation indicating the grant was utilized for the purpose for which it was intended.
